Dear Resident,

We're writing to inform you that pursuant to the project permitting requirements, South Fork Wind is offering to perform free pre- and post-construction water turbidity testing for all known existing and active drinking water supply wells that fall within one hundred feet of the planned onshore transmission cable. Your property has been identified within this radius.

Water turbidity testing measures the water clarity to identify the presence of material such as clay and silt.

If a New York State Department of Health certified laboratory test concludes that the water turbidity from an existing, active drinking water supply well was less than the New York State standard of 5 Nephelometric Turbidity Units for drinking water prior to construction, but failed to meet such standards post construction, then you will be eligible for a new water well to be constructed. Please note that **pre-construction testing is required to be completed prior to construction to obtain post-construction testing.**

To facilitate this test, access must be granted by the property owner or current resident to an Environmental Specialist who will collect a small sample from the expansion tank within the home. This activity will take less than thirty minutes to complete.

If your property is connected to a public water supply (provided by the Suffolk County Water Authority), you may disregard this letter. If your property contains an active drinking water supply well and you are interested in our team providing a turbidity test, please respond to this letter using one of the options below to indicate your participation, permission for access, and availability. Pre-construction testing is scheduled to begin the week of 12/6/21 and is anticipated to be complete within 4-weeks.
